# 12:45-1:30pm (45) Leveraging Payer Scorecards & National Data for Financial Success

In an era of increasing denials, down coding, delayed payments, and reduced reimbursement, providers need more than anecdotal evidence—they need data. This session will focus on how hospitals and health systems can use a national, provider-based payer scorecard to identify and address systemic payer behaviors. Developed in partnership with HFMA, NRHA, and state hospital associations, the scorecard leverages real-time claims and remittance data to hold payers accountable and empower providers to move from defense to offense in the fight for fair reimbursement.
