# Utilities, Construction Best Practices, Tuning your Building & TAB/CX Efforts to Save \$1 Billion in Healthcare

Michael Hatton MBA, CHFM | Vice President | Memorial Hermann

This presentation will provide observations, strategies, supporting best practices, and outcomes from Memorial Hermann's focus on Operational Efficiency; Capital Projects Delivery, Recruitment and Succession Planning, as well as discussing the importance of Quality Control with capital construction and renovations. In addition, Best Practices related to both facility management operations and construction are outlined along with efficiency improvements with utility consumption/energy management and the resultant improvements with facility resiliency — all as a result of the synergies of teamwork between project management, facility managers, and trusted business partners, who together have delivered over \$3.5 billion in healthcare projects over the last 5 years in the Houston, Texas marketplace

### **George Mills**

George Mills has more than 40 years in healthcare, including 14 years at the Joint Commission as director of engineering. He has also worked for two years for the AHA Personal Membership Group ASHE, as director of codes and standards. His remaining work in healthcare includes Facilities Management, serving 2.5 years at ATG as the CEO, and seven years as the Director of Technical Operations with JLL. Prior to working in healthcare Mr. Mills was a carpenter and iron worker. He has an MBA from California Coast University, is certified as a CHFM, CHSP and CHOP-DNV; CEM-R (retired); and he is a Fellow with ASHE, AAMI and the RSPH. He has authored books and many articles and is a nationally recognized speaker.

#### Michele Mucia

Michele is a 20-year healthcare veteran with B.S. degrees in Education, Business Management and working toward her M.S. Healthcare Construction Management. Her experience has been dedicated to the healthcare industry throughout her career. Her expertise encapsules CMS compliance & NFPA codes/standards within the physical environment by way of survey processes & Asset Management platforms. Michele is a member of NFPA, ASHE & THEA, HESNI, KSHE, SCSHE, CNYHE & TAFHM. She has certifications in CHSP-FM, HACP and is a current Principal to NFPA 99 (since 2016), & NFPA 101 in years past. She was recently appointed to ASTM International Global as an FCA committee member & ASHE MTC Committee member for HFM Magazine and Tools. Her expertise in the use of KPI Analytical compliance assessments/inspections & data driven strategies has proven to increase FCI health in infrastructure, lean FTE facilities operations processes & compliance.

### Michael Hatton, MBA, CHFM

Michael Hatton, Vice President, manages "facilities" and construction for Memorial Hermann in Texas. In the previous 48 months, he has delivered 6 major expansions in Houston with a capital cost approaching \$2 billion. Currently, Mike leads over 400 projects (~\$2.3 billion) in the marketplace as Memorial Hermann expands its footprint to keep up with growth in the region. Under his leadership, Memorial Hermann has driven over \$190 million to the bottom line, reduced natural gas >59%, improved kBtu/sqft by 25.3%, and subsequently, reduced emissions 22.4% as a result of education, retro-commissioning, and benchmarking. More importantly, Memorial Hermann builds a better building, with a requirement to be Energy Star Labeled. Memorial Hermann has 10 Energy Star labeled hospitals; 2 facilities are ranked at Energy Star 100, and 7 other hospitals above the 90th percentile! Mike is the 2025 President of ASHE, a professional member group of the AHA.
